

# COMMUNITY **UPDATE**



- 1. Tower 2 & 3 (22 storey and 20 storey residential towers): Bathroom POD load out complete up to levels 19 and 14 respectively KEY:
  - 2. Tower 1 (34 storey residential tower): Concrete core poured up to level 31
  - 3. New UAL: LCC Campus Building: Concrete structure complete and steel installation ongoing
- The Integrated ticket hall structure has progressed with prop removal and forming of the ground floor slab currently in progress.
- The E1 (12 storey new UAL : LCC campus building) concrete structure is now complete with steel installation ongoing to level 11.
- The façade install has progressed up to level 7 to all elevations.
- The Building Maintenance Unit is now installed and being commissioned on level 12.
- The tower 1 (34 storey residential tower) concrete core is now poured up to level 31 on the south elevation and level 26 on the north elevation.
- The precast façade has progressed up to Level 18 with bathroom PODs loaded out to level 22. Fit out is also progressing ahead of the facade installation with flat duct and cable loom installed up to level 24.

- The tower 2 (20 storey residential tower) and tower 3 (22 storey residential tower) concrete cores and slabs are now both complete.
- The façade panel installation has also commenced in the residential areas up to level 14 in (tower 2) and level 10 to (tower 3) and the bathroom POD load out has commenced up to level 19 (tower 2) and level 14 (tower 3).
- There are currently three vehicle entry/exit gates and two external pit lanes in use across the project, managed by teams of dedicated trained traffic marshals through Multiplex's supply chain partner, Clipfine.
- At present, approximately 780 people are working on the project every day, from operatives (c. 650) to management staff (c. 130).

# COMMUNITY UPDATE



Multiplex's supply chain partner, MAC Roofing, has recently hired a local Southwark resident and they will join the project full time.

In July, five work experience students joined the Multiplex team. Two of these students undertook a general placement on the project, spending time with the various teams to gain a basic understanding of a live construction project. Two students were on a specific BIM (Building Information Modelling) placement and spent time with Multiplex's Legal and Communications Teams at the head office, in addition to attending a variety of site tours.

Multiplex, together with supply chain partners Hall & Kay and Errigal, participated in the Elephant and Castle Town Centre Careers Fair at Southwark College on 27th June. The Careers Fair had a fantastic turnout, with lots of students engaging with our team present on the day.

Two monitors from their third party ethical labour auditor attended the site on July 9th to talk anonymously to the workforce. It was confirmed that no evidence of modern slavery was identified and the level of modern slavery awareness within the workforce was very high, indicating that the Multiplex team is fully aware of the support systems available on the project should there be any concerns.

## **ENVIRONMENTAL SUSTAINABILITY UPDATE**

### **WASTE MINIMISATION**

Multiplex continues to utilise waste compactors onsite. This has paid dividends in ensuring waste movements are kept to as little as possible. The compactors ensure that waste being taken away is being packed as efficiently as possible.

## **PLASTIC FREE JULY**

The project has re-focused its policy around eliminating single use plastic. This involves the delivery of seven office items, five welfare items, and three site items of plastic that need elimination. A further audit is being conducted across all trades.
